



# CITY OF CLAY, ALABAMA ORDINANCE 2016-08

## AN ORDINANCE ESTABLISHING COMMITTEES FOR THE TERM NOVEMBER 2016 THROUGH OCTOBER 2020

BE IT ORDAINED BY THE CITY COUNCIL OF CLAY, ALABAMA that the following City Council Standing Committees shall be established, to wit:

**Section 1.** The Committee on Economic Development consisting of Councilor Bo Johnson, Chairman, and Councilors Dennis Locke and Ben Thackerson.

**Section 2.** The Committee on Parks and Recreation consisting Councilor Ben Thackerson, Chairman, and Councilors Don Baker and Becky Johnson.

**Section 3.** The Committee on Public Safety consisting of Councilor Don Baker, Chairman, and Councilors Becky Johnson and Bo Johnson.

**Section 4.** The Committee on Senior Citizens consisting of Councilor Becky Johnson, Chairman, and Councilors Dennis Locke and Ben Thackerson.

**Section 5.** The Committee on Schools consisting of Councilor Dennis Locke, Chairman, and Councilors Don Baker and Bo Johnson.

**Section 6.** All Committees will meet on the third Tuesday of the first month of each quarter.

**Section 7.** All meetings shall convene at 6:00 P.M. in the Council Chambers at Clay City Hall and all meetings, regular and special, shall be open to the public.

**Section 8.** Any and all Ordinances or Resolutions in conflict with this Ordinance are hereby repealed.

**Section 9.** The parts of this Ordinance are severable and should any part or parts be declared invalid by a court of competent jurisdiction, such ruling shall not affect the remaining parts.

**Section 10.** This ordinance shall go into effect upon the passage and publication as required by law.
