That on the 6<sup>th</sup> day of February, 2012, in the regularly scheduled City Council meeting a public hearing will be held to determine the truths of the matter set forth in said petition and to consider any protests or objections filed in writing with the City Clerk prior to such hearing, to determine whether it is in the public interest or not that said property be annexed into the City of Clay, Alabama and to consider adoption of an Ordinance annexing said territory.
