STATE OF ALABAMA JEFFERSON COUNTY CITY OF CLAY

A RESOLUTION ABATING WEEDS ON THE PROPERTY LOCATED AT 8060 CLAYTON ROAD, PINSON, ALABAMA 35126

WHEREAS, THE City Council of the City of Clay, Alabama adopted Ordinance 2010-03 on the 15th day of February, 2010; and

WHEREAS, said Ordinance was adopted to control and abate the nuisance created by overgrown grass and weeds within the City Limits of Clay, Alabama that may be injurious to the general public health, safety and general welfare by providing breeding grounds and shelter for rats, mice, snakes, mosquitoes, and other vermin, insects, and pests or attaining heights and dryness that constitute a serious fire threat or hazard; or bearing wingy or downy seeds, when mature, that cause the spread of weeds, and when breathed, irritation to the throat, lungs, and eyes of the public; or hiding debris, such as broken glass or metal, that could inflict injury on a person going upon the property; or being unsightly; or growth of grass or weeds, other than ornamental plant growth, that exceeds twelve (12) inches in height; and

WHEREAS, upon inspection of the City Manager and Public Works Supervisor, this property was found to be a public health hazard from an evicted foreclosure.

WHEREAS, City Hall made multiple attempts to contact mortgage company about cleaning this up and no one would accept responsibility. Mortgage company was made aware that the house was a hazardous situation and would be cleaned up and a lien placed on the property.

WHEREAS, the Public Works Superintendent has submitted the cost of said abatement in a report filed and attached to this Resolution in the amount of \$9,558.87.

NOW, THEREFORE BE IT RESOLVED that the City Council authorizes the City Manager to file with the Probate Court of Jefferson County a lien for said abatement in the amount of \$9,558.87
