**A Resolution Proposing the Annexation of Certain Territory
to the Corporate Limits of the City of Clay, Alabama**

WHEREAS, the Department of Youth Services has filed a petition to annex the property known as the Department of Youth Services – Chalkville Campus as identified in said petition with the City Clerk of the City of Clay, Alabama; and

WHEREAS, the property identified in the petition is contiguous to the city limits of the City of Clay; and

WHEREAS, said petition is herein presented to the City Council of the City of Clay, Alabama.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Clay, Alabama as follows:

1. That the said petition shall be posted in accordance with the laws of the State of Alabama at Chalkville Regions Bank, Clay City Hall, Clay Post Office and the Clay Seniors Center all located in the City of Clay.
2. That on the 6th day of February, 2012, in the regularly scheduled City Council meeting a public hearing will be held to determine the truths of the matter set forth in said petition and to consider any protests or objections filed in writing with the City Clerk prior to such hearing, to determine whether it is in the public interest or not that said property be annexed into the City of Clay, Alabama and to consider adoption of an Ordinance annexing said territory.
