Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Bo Johnson, Chris Nail, Orletta Rush and Mayor Webster. Absent: Councilor Dean Kirkner
