CITY COUNCIL MINUTES October 8th, 2024

The City Council of the City of Clay met in regular session on Tuesday, October 8th, 2024, at 6:00 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon served as recorder.

Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Bo Johnson, Orletta Rush and Mayor Webster.

Mayor Webster called for a motion to approve the Council meeting minutes of September 24th, 2024. Councilor Orletta Rush made a motion to approve the Council meeting minutes of September 24th, 2024, which was seconded by Councilor Bo Johnson and approved by a unanimous voice vote.
