Councilor Chris Nail led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush and Mayor Webster
