### **September 10th, 2019**

The City Council of the City of Clay met in regular session on Tuesday, September 10th, 2019, at 6:30 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon served as recorder.

Mayor Webster called the meeting to order. Councilor Bo Johnson opened in prayer. Mayor Webster led everyone in the Pledge.

Roll call of those present was answered by the following: Councilor Becky Johnson, Councilor Bo Johnson, Councilor Dean Kirkner, and Mayor Webster.

Under **Reading of Petitions, Applications, Complaints, Appeals, Communications, etc.**, Mayor Webster announced there were none.

Under the **City Manager's report**, Mr. Dixon reported the account balances in the General Fund = \$378,424.15; Contractors Bond = \$151,981.80; Capital Improvement Fund = \$255,395.79; 4 & 5 Cent Gasoline Fund = \$68,437.44; 7 Cent Gasoline Fund = \$6,297.99; Building Fund = \$643,098.92; Paving Supplement Fund = \$257,357.05; Contingency Fund = \$1,100,000.00; BBT Fund = \$35,205.36; Ballpark Registration Income = 79,431.30; and Ballpark Sports Expense = (88,074.66). Mr. Dixon introduced Wayne Odell representing Wreaths Across America. Mr. Odell read the five names of service members who were killed in action from our area. Johnathan Millican of Locust Fork, Kelly Pruitt of Cathedral of the Cross, William Monzдал of Pinson Valley, Michael Hosey of Clay Chalkville and Jason Stegall of Hewett Trussville.

The ceremony for Wreaths Across America will be held December 14<sup>th</sup> at 11 am.
