STATE OF ALABAMA JEFFERSON COUNTY CITY OF CLAY

A Resolution for the Election Results For City Council - Place 5

WHEREAS, the general election for the City of Clay was duly and legally held on August 28, 2012, as provided by law; and

WHEREAS, the municipal governing body of the City of Clay met on the 4th day of September, 2012, all members thereof being present or a quorum thereof being present, at 7:00 o'clock p.m., and canvassed the returns, and ascertained and determined the number of votes received by each candidate; and

WHEREAS, the said municipal governing body did ascertain and determine the result of said election for Mayor, City Council - Place 1, and City Council – Place 3, and

WHEREAS, it was determined that no candidate received a majority of the votes cast for the office of City Council - Place 5, and that Ricky Baker and Jackie Hambrick received the most and second most votes cast for that office, therefore, a runoff election between said candidates was ordered to be held on Tuesday, October 9, 2012, pursuant to the requirements of Section 11-46-20 et seq., of the Alabama Code of 1975, as amended. And

WHEREAS, on September 6, 2012, Jackie Hambrick did present a letter to the Mayor stating that “due to unforeseen circumstances relating to my health, I will not be able to participate in the City of Clay runoff with Ricky Baker for place five as councilor” and said letter is hereby attached as a part of this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Clay, Alabama as follows:

That, based on Jackie Hambrick’s notice of withdrawal, Ricky Baker is hereby declared duly elected to that office for the term beginning on the first Monday in November, 2012.
