## A RESOLUTION CHANGING THE APRIL 28, 2026, PRE-COUNCIL AND REGULAR MEETING DATE OF THE CITY COUNCIL OF THE CITY OF CLAY DUE TO A LACK OF QUORUM CAUSED BY THE ALABAMA LEAGUE OF MUNICIPALITIES ANNUAL CONVENTION

**WHEREAS**, the City Council of the City of Clay, Alabama, establishes its regular meeting dates by resolution and custom in accordance with the Code of Alabama 1975; and

**WHEREAS** the Alabama League of Municipalities Annual Convention is scheduled during the same week as the City Council's regular meeting date of April 28, 2026; and

**WHEREAS** multiple members of the City Council will be attending the Alabama League of Municipalities Annual Convention in their official capacities; and

**WHEREAS**, due to such attendance, a quorum of the City Council will not be available to conduct official City business on April 28, 2026; and

**WHEREAS** it is necessary and in the best interest of the City to reschedule the April 28, 2026, meetings to ensure the presence of a quorum and the orderly conduct of municipal business.

**NOW THEREFORE, BE RESOLVED**, by the City Council of the City of Clay that:

1. The pre-council and regular City Council meetings scheduled for Tuesday, April 28, 2026, are hereby canceled due to the anticipated lack of a quorum resulting from the Alabama League of Municipalities Annual Convention.
2. The April 28, 2026, meetings are hereby rescheduled to Tuesday, April 21, 2026, beginning at 6:00 pm., to be held at the regular meeting place of the City Council, unless otherwise noticed.
3. The City Clerk is hereby directed to provide proper public notice of the changed meeting date and time in accordance with applicable law.
4. All other regularly scheduled City Council meetings shall remain unchanged unless otherwise modified by subsequent action of the City Council.
