The City Council of the City of Clay met in regular session on Tuesday, January 14<sup>th</sup> 2025 at 6:00 p.m. at Clay City Hall. Mayor Charles Webster presided over the meeting and Andrea Self served as recorder.

Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Bo Johnson, Dean Kirkner, Chris Nail, Orletta Rush and Mayor Webster.
