CITY COUNCIL MINUTES October 28th, 2025

The City Council of the City of Clay met in regular session on Tuesday, October 28th, 2025, at Clay City Hall. Mayor Charles Webster presided over the meeting and Ronnie Dixon served as recorder.

Mayor Webster led in prayer and led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster

Mayor Webster called for a motion to approve the Council meeting minutes of October 14th, 2025. Councilor Dean Kirkner made a motion to approve the Council meeting minutes of October 14th, 2025, which was seconded by Councilor Orletta Rush and approved by a vote of unanimous voice.
