## STATE OF ALABAMA JEFFERSON COUNTY CITY OF CLAY

## A Resolution to Award a Bid for Garbage Contract

WHEREAS, the City of Clay, Alabama, desires to enter into a contract for the citizens of Clay for a garbage and trash pickup, and

**WHEREAS,** The City Council of the City of Clay, Alabama has solicited competitive bids pursuant to the Public Works Bid Law, Act 97-225 of the Alabama Legislature, for the collection of garbage, recyclables, and/or trash at designated drop off points; and,

**WHEREAS**, the invitation for bids was advertised with the opening date set forth in the bids and the City Council opened said bids in its regular City Council meeting of February 18, 2013 the total bids being as follows:

**NOW THEREFORE, BE IT FURTHER RESOLVED,** that the Mayor is authorized to sign the contract in the name of the municipality, with the City Manager's attestation to the Mayor's signature.
