Mr. Dixon reported the account balances in the General Fund = \$296,967.93; Contractors Bond = \$152,044.80; Capital Improvement Fund = \$471,431.75; 4 & 5 Cent Gasoline Fund = \$77,028.36, 7 Cent Gasoline Fund = \$33,924.15; Building Fund = \$700,000.00; Paving Supplement Fund = \$300,000.00; Contingency Fund = \$1,100,000.00; BBT Fund= \$59,277.68; Ballpark Registration Income =11,345.00 and Ballpark Sports Expense =(5,821.92).

Mayor called for a motion to move to unanimous consent. *Councilor Dennis Locke made a motion to move to unanimous consent which was seconded by Councilor Don Baker and approved by a unanimous voice vote*

Resolution 2017-43 to designate the City of Clay as General Contractor for the Construction of a Public Library Building. *Councilor Don Baker made a motion to approve resolution 2017-43 as amended which was seconded by Councilor Locke and approved by a unanimous voice vote.*
