The City Council of the City of Clay met in regular session on Tuesday, December 10th, 2024, at 6:00 p.m. at Clay City Hall. Mayor Charles Webster presided over the meeting and Andrea Self served as recorder.

Councilor Nail led in prayer. Mayor Webster led the Pledge of Allegiance.
