RESOLUTION 2012 - 13

A Resolution to Award a Bid for Resurfacing Keith Drive and Pannell Road

WHEREAS, The City Council of the City of Clay, Alabama has solicited competitive bids pursuant to the Public Works Bid Law, Act 97-225 of the Alabama Legislature, for the resurfacing of sections of Frazier Circle, Shane Circle, Keith Drive, Pannell Road, and Uphill Drive; and,

WHEREAS, The City Council resolves to let the bid to the lowest responsible bidder, according to the special specifications determined and placed on file with the City Clerk; and,

WHEREAS, the invitation for bids was advertised with the opening date set forth in the bids and the City Council opened said bids in its regular City Council meeting of June 18, 2012, the total bids being as follows:

WHEREAS, it has been determined that the City will resurface Keith Drive and Pannell Road at this time,

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Clay that Joshco Inc. dba Butler Contractors is determined to be the lowest responsible bidder, the bid amounts \$17,580.00 for Keith Drive, and \$41,251.00 for Pannell Road and that a contract will be awarded to such bidder.

NOW THEREFORE, BE IT FURTHER RESOLVED, that the Mayor is authorized to sign the contract in the name of the municipality, with the Clerk's attestation to the Mayor's signature.
