## STATE OF ALABAMA JEFFERSON COUNTY CITY OF CLAY RESOLUTION 2012 - 08

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH THE JEFFERSON COUNTY COMMISSION TO PROVIDE VOTING MACHINES AND OTHER EQUIPMENT FOR THE 2012 MUNICIPAL ELECTION IN CLAY, ALABAMA

WHEREAS, the City of Clay will hold its quadrennial municipal election for the purpose of electing a mayor and five council persons; and

WHEREAS, the City of Clay has used the Jefferson County voting machines in past elections, and desires to continue to use this equipment; and

WHEREAS, the City of Clay has established two polling locations for the 2012 municipal election, those locations being Clay Community Center, 6411 Clay Palmerdale Road and Clearview Baptist Church, 5271 Old Springville Road ; and

WHEREAS, the City of Clay will require five (5) voting machines for the general election and the run-off election, if necessary, with two (2) voting machines being regular voting machines and three (3) being handicap accessible voting machines. One (1) handicap accessible voting machine to be delivered to City Hall; one (1) regular voting machine and one (1) handicap accessible voting machine to be delivered to the Clay Community Center, and one (1) regular voting machine and one (1) handicap accessible voting machine to be delivered to Clearview Baptist Church.

IN ADDITION, to the above voting machines, the City will purchase voter list for posting as required by law and one each laptop/electronic poll book for each polling place. These laptop/poll books shall contain a complete list of each voter's name, address, and polling location.

NOW THEREFORE be it resolved that the City Council of the City of Clay, Alabama authorizes the Mayor to enter into a contract with the Jefferson County Commission to furnish the above voting machines, laptop/electronic poll books and voter list for the 2012 municipal election in the City of Clay, Alabama.
