**A RESOLUTION APPOINTING MEMBERS TO THE CITY OF CLAY YOUTH SPORTS ADVISORY BOARD**

**WHEREAS**, pursuant to Sections 11-86-1 through 11-86-6, Code of Alabama 1975, the City Council of the City of Clay, Alabama, is authorized to establish and maintain youth recreational and athletic advisory boards to assist the municipality in the promotion and administration of youth sports and recreational programs; and

**WHEREAS**, the City Council adopted Resolution No. 2026-15 establishing the City of Clay Youth Sports Advisory Board; and

**WHEREAS**, the City Council has received applications from interested residents and has determined that the nominees possess the qualifications and interest necessary to serve the citizens of the City of Clay in this capacity;

  - e. Place #5 – Term expiring September 30, 2031

3. The City Clerk is directed to:
  - a. Notify the appointee(s) of their appointment; and
  - b. Update the official records of the **City of Clay Youth Sports Advisory Board**.

- 5. The Mayor and staff are hereby authorized to take all actions and execute all documentation necessary to carry out the intent and purpose of this Resolution.
