The City Council of the City of Clay met in regular session on Monday, December 5, 2016, at 6:30 p.m. at Clay City Hall. Mayor Webster presided over the meeting and City Manager Ronnie Dixon, served as recorder.

Under **Mayor and Council Comments**, **Mayor Webster** reported that the City has received several thank you letters from veterans who attended the Veterans Day Luncheon.

**Councilor Baker** reported that the burn ban has been lifted, but that anyone who burns must have a permit from Jefferson County Department of Health. He also expressed concern about on-street parking on Balboa Avenue. Mr. Dixon assured him that the deputies will patrol the area to look for parking violations.

**Councilor Becky Johnson** announced that the Christmas parade is Saturday, December 10 at 3:00 pm; the Grand Marshall is Clay Chalkville High School principal, Mr. Lee.

**Councilor Bo Johnson** had nothing new to report.

**Councilor Locke** had nothing new to report.

**Councilor Thackerson** asked for progress on the girls' school property. Mayor Webster informed the council that the Department of Youth Services will meet at 9:00 am on Friday.

Under **Reading of Petitions, Applications, Complaints, Appeals, Communications, etc.**, Mayor Webster announced that there were none.

Under the **City Manager's Report**, Mr. Dixon reported the account balances in the General Fund = \$252,597.89; Contractors Bond = \$74,559.93; Capital Improvement Fund = \$420,814.08; 4 & 5 Cent Gasoline Fund = \$115,305.12; 7 Cent Gasoline Fund = \$56,081.27; Building Fund = \$200,000.00; Paving Supplement Fund = \$325,000.00; Contingency Fund = \$1,000,000.00; BBT Fund = \$44,213.84; Ballpark Registration Income = \$8,740.00; and Ballpark Sports Expense = (\$12,642.93).

Mr. Dixon introduced Code Enforcement Officer, Jason Harris. He reported that Mr. Harris was previously employed in the Public Works Department and reviewed Mr. Harris's new duties.

Under the **Public Hearing**, Mayor Webster announced there were none.

Under **Resolutions, Ordinances, Orders and Other Business** Mayor Webster announced there were none.

Mayor Webster called for **Public Comments** and there was no response.

Mayor Webster announced that the next City Council meeting will take place on Monday, December 19, 2016, at 6:30 pm.

*Councilor Baker made a motion to adjourn which was seconded by Councilor Bo Johnson and approved by a unanimous vote.*
