## CITY COUNCIL MINUTES June 15th, 2021

The City Council of the City of Clay met in regular session on Tuesday, June 15th, 2021, at 6:00 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon served as recorder.

Mayor Webster called the meeting to order and roll call was conducted as follows:

Present: Councilors Becky Johnson, Bo Johnson, Dean Kirkner, Chris Nail and Mayor Webster

Absent:

Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called for a motion to approve the Council meeting minutes of May 25th, 2021. *Councilor Dean Kirkner made a motion to approve the Council meeting minutes of May 25th, 2021, which was seconded by Councilor Becky Johnson and approved by a unanimous voice vote.*

Mayor Webster called for a motion to approve tonight's Meeting Agenda. *Councilor Dean Kirkner made a motion to approve tonight's Meeting Agenda, which was seconded by Councilor Bo Johnson and approved by a unanimous voice vote.*

Mayor Webster called for a motion to approve tonight's Consent Agenda. *Councilor Becky Johnson made a motion to approve tonight's Consent Agenda, which was seconded by Councilor Kirkner and approved by a unanimous voice vote.*

*Councilor Kirkner requested to suspend the regular agenda. Councilor Becky Johnson made a motion to suspend agenda which was seconded by Councilor Bo Johnson and approved by a unanimous voice vote. Mayor Webster announced a new member appointment to City Council Chris Nail. Councilor Dean Kirkner made a motion to approve the appointment which was seconded by Councilor Bo Johnson and approved by a unanimous voice vote. Chris Nail was sworn into office. Mayor Webster announced a new appointment to the Planning and Zoning committee, Dr. Orleta Rush to begin in July.*

Under **Public Hearings** there were none.

Under the **City Manager's report**, City Manager Ronnie Dixon reported the Fund Balances as follows: General Fund \$1,416,882.26, Vehicle Registration \$23,445.81, Contractor Bonds \$155,965.16, Capital Fund \$602,431.17, 4 & 5C Gas Fund \$211,197.93, 7 C Gas Fund \$141,643.09, Rebuild Alabama Gas Fund \$82,9532.33, Building Fund \$0.00, Paving Supplement Fund \$256,840.98, Reserve Fund \$1,750,000.00, BBT Fund \$17,383.04, BP Sports Income \$28,184.98, BP Sports Expenses (\$21,532.39). Ballpark has 60 cheerleaders and have ordered uniforms. Pot holes and paving list has been sent to Campbells and should be done in the next few weeks. The Splash Pad will open on June 19<sup>th</sup>.

Under **Resolutions, Ordinances, Orders and other Business**. Mayor Webster called for a motion to move to unanimous consent. *Councilor Dean Kirkner made a motion to move into unanimous consent which was seconded by Councilor Bo Johnson.* The motion was put before the Council and a roll call vote was conducted with the results as follows: *Yeas: Councilors Johnson, Johnson, Kirkner, Nail and Mayor Webster.*

Mayor Webster introduced Resolution 2021-11 declaring weeds to be a public nuisance at various addresses. *Councilor Dean Kirkner made a motion to approve Resolution 2021-11 which was seconded by Becky Johnson.* The motion
