The City Council of the City of Clay met in regular session on Tuesday, September 14, 2021, at 6:00 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon, served as recorder.

Mayor Webster called the meeting to order and roll call was conducted as follows:
