CITY COUNCIL MINUTES March 14th, 2023

The City Council of the City of Clay met in regular session on Tuesday, March 14th, 2023, at 6:00 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon served as recorder.

Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Bo Johnson, Dean Kirkner, Chris Nail and Mayor Webster Absent: Councilor Orletta Rush

Mayor Webster called for a motion to approve the Council meeting minutes of February 28th, 2023. Councilor Dean Kirkner made a motion to approve the Council meeting minutes of February 28th, 2023, which was seconded by Councilor Bo Johnson and approved by a unanimous voice vote.
