CITY COUNCIL MINUTES March 26th, 2024

The City Council of the City of Clay met in regular session on Tuesday, March 26th, 2024, at 6:00 p.m. at Clay City Hall. Mayor Webster presided over the meeting and Ronnie Dixon served as recorder.

Councilor Bo Johnson led in prayer. Mayor Webster led the Pledge of Allegiance.
