## A RESOLUTION DECLARING WEEDS TO BE A PUBLIC NUISANCE

**WHEREAS**, the City Council of the City of Clay, Alabama adopted Ordinance 2010 – 03 on the 15<sup>th</sup> Day of February, 2010; and

**WHEREAS**, said Ordinance was adopted to control and abate the nuisance created by overgrown grass and weeds within the City Limits of Clay, Alabama that may be injurious to the general public health, safety and general welfare by providing breeding grounds and shelter for rats, mice, snakes, mosquitoes, and other vermin, insects, and pests or attaining heights and dryness that constitute a serious fire threat or hazard; or bearing wingy or downy seeds, when mature, that cause the spread of weeds, and when breathed, irritation to the throat, lungs, and eyes of the public; or hiding debris, such as broken glass or metal, that could inflict injury on a person going upon the property; or being unsightly; or growth of grass or weeds, other than ornamental plant growth, that exceeds twelve (12) inches in height.

**NOW THEREFORE BE IT RESOLVED**, that the City Council of the City of Clay, Alabama declares the following properties to be a public nuisance:

5543 Spanish Trace	PID = 12-00-04-4-002-002.059

6209 Eagle Ridge Circle	PID = 09-00-26-3-000-046.000

NOW THEREFORE BE IT FURTHER RESOLVED, that the City Council of the City of Clay, Alabama will conduct a Public Hearing during the regularly scheduled City Council meeting on Tuesday, September 13, 2022 to consider all evidence, objections and protests regarding the proposed removal of weeds and/or all other materials that may be considered a nuisance as identified above.
