CITY COUNCIL MINUTES September 23rd, 2025

The City Council of the City of Clay met in regular session on Tuesday, September 23rd, 2025 at Clay City Hall. Mayor Charles Webster presided over the meeting and Ronnie Dixon served as recorder.

Mayor Webster led in prayer and led the Pledge of Allegiance.

Mayor Webster called the meeting to order and roll call was conducted as follows: Councilors Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster

Mayor Webster called for a motion to approve the Council meeting minutes of September 2nd, 2025. Councilor Dean Kirkner made a motion to approve the Council meeting minutes of September 2nd, 2025, which was seconded by Councilor Orletta Rush and approved by a vote of unanimous voice.

Mayor Webster called for a motion to approve today's Meeting Agenda. The Mayor amended the agenda to remove some of the properties from the resolution for weeds. Councilor Orletta Rush made a motion to approve the amended Meeting Agenda as amended, which was seconded by Councilor Chris Nail and approved by a unanimous voice vote.

Mayor Webster called for a motion to approve today's Consent Agenda. Councilor Orletta Rush made a motion to approve the Consent Agenda, which was seconded by Councilor Dean Kirkner. The motion was put before the Council and a roll call vote was conducted with the following result: Yeas: Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster.

Under Reading of Petitions, Applications, Complaints, Appeals and Communications there were none.

City Manager's Report: Mr. Dixon presented the 2025-2026 Budget. Councilor Orletta Rush made a motion to approve the budget which was seconded by Councilor Dean Kirkner. The motion was put before the Council and a roll call vote was conducted with the following result: Yeas: Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster.

Under Public Hearings: ALC-2025-06 License for Spike Liquor store. The owner was present to answer questions from the Council. Citizen Deanna Hunt spoke against and requested change to the hours. Councilor Dean Kirkner made a motion to approve ALC-2025-06 which was seconded by Councilor Chris Nail. The motion was put before the Council and a roll call vote was conducted with the following result: *Yeas: Dean Kirkner, Chris Nail, Orletta Rush, and Mayor Webster. Nays: Councilor Becky Johnson and Nathan Thompson*

ALC-2025-07 Chelsea Blues Liquor Store (owner change only) The owners were present to answer questions from the Council. There was no one present to speak against. Councilor Orletta Rush made a motion to approve ALC-2025-07 which was seconded by Councilor Nathan Thompson. The motion was put before the Council and a roll call vote was conducted with the following result: Yeas: Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster.

Weeds: 5902 Elizabeth Dr, 6511 Self Lane and 6512 Self Lane. The owner of 6512 Self Lane was present to speak against. The Mayor removed the property from the agenda to be reviewed at a later date.

Personal Property: 7112 Self Road. There was no one to speak for or against.

Under Resolutions, Ordinances, Orders, and other Business, Mayor Webster called for a motion to move to unanimous consent. Councilor Dean Kirkner made a motion to move to unanimous consent which was seconded by Councilor Orletta Rush. The motion was put before the Council and a roll call vote was conducted with the results as follows: Yeas Councilors; Becky Johnson, Dean Kirkner, Chris Nail, Orletta Rush, Nathan Thompson and Mayor Webster.

Ronnie Dixon introduced Ordinance 2025-07. An Ordinance Rescinding Ordinances 2014-04 and 2015-19. *Councilor Dean Kirkner made a motion to approve Ordinance 2025-07 which was seconded by Councilor Chris Nail.* Under discussion Mr. Thompson confirmed with Mayor Webster that the General Fund budget could be covered without the income from the ad valorem tax.
