## CITY COUNCIL MINUTES August 30, 2016

The City Council of the City of Clay met in a special session on Tuesday, August 30, 2016, at 12:00 p.m. noon at Clay City Hall. Mayor Webster presided over the meeting and City Manager Ronnie Dixon, served as recorder.

Mayor Webster called the meeting to order. Councilor Bo Johnson opened in prayer and Mayor Webster led everyone in reciting the Pledge of Allegiance.

Roll call of those present was answered by the following:

Councilor Baker, Councilor Becky Johnson, Councilor Bo Johnson, Councilor Thackerson, and Mayor Webster

Absent: Councilor Small

Mayor Webster announced there were no minutes or consent agenda to approve and called on Mr. Dixon to read Ordinance 2016-06.

Mr. Dixon explained that the purpose of this meeting is to canvas the election results from the municipal election that took place on Tuesday, August 23, 2016. He further explained that each councilor has received a copy of the results tabulation sheet as well as Ordinance 2016-06. The Council and Mr. Dixon verified that the results tabulation sheet matched the poll numbers submitted by the poll workers.

Under **Resolutions, Ordinances, Orders and Other Business** Mayor Webster called for a motion to enter into Unanimous Consent.

Mayor Webster introduced Ordinance 2016-06, An Ordinance Canvassing Election Results, which was read by City Manager Ronnie Dixon.

*Councilor Baker made a motion to approve Ordinance 2016-06, which was seconded by Councilor Thackerson.* The motion was put before the Council and a roll call vote was conducted with the results as follows:
